

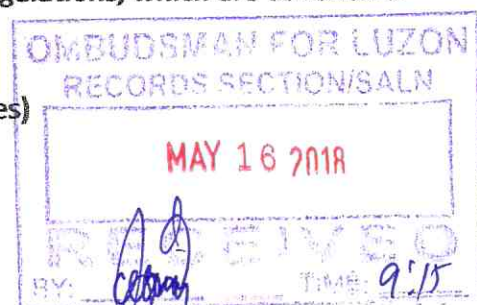


CERTIFICATION OF COMPLIANCE SALN Submission/Filing

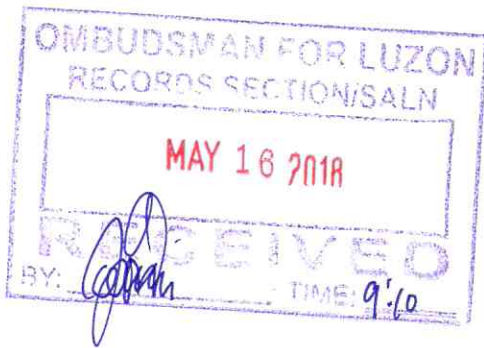

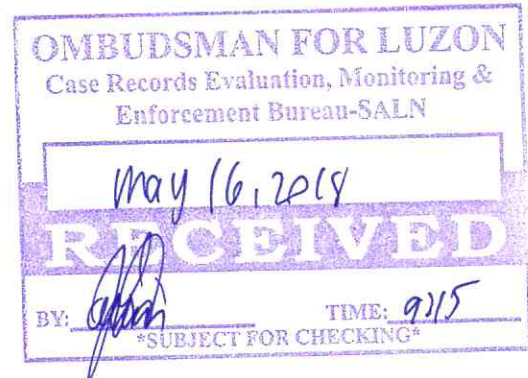
